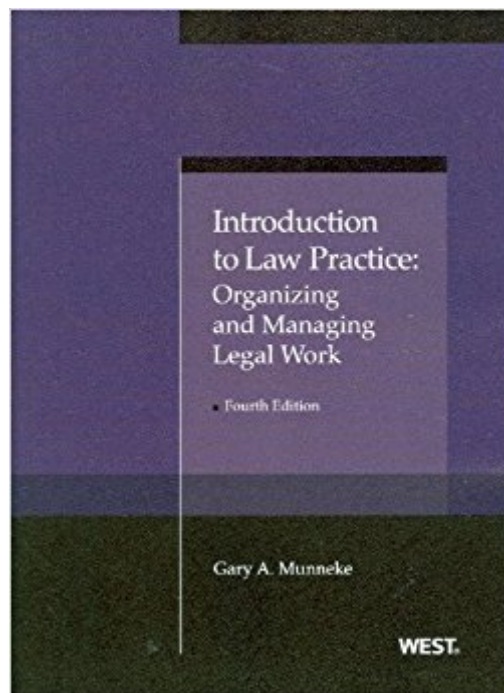

Ok, this book seems to be a cash grab. It was last published in 2013, but still includes a 2001 article in chapter 14 about the relative merits of a Personal Digital Assistant (PDA), another 2001 article about the benefits of going paperless in an office. In fact, the whole chapter on Practice System components comes from the turn of the century. Technology and innovation have moved way beyond where this book is. It appears that the author just upped the edition number without really revising this book. It also includes "relevant" topics like how to feng shui your legal office if you are really interested.
