

Basic tax code, used for my tax classes in law school. I strongly suggest that anyone else using this book for tax class not count on using the "tax map" as a crutch, ex. on open-book exam, because I know many people who did not do well in their courses because of it. Read the code section, then read the regs to understand them.

Thorough with all the important statutes of the tax code in it. The map provides the big picture which is helpful because the individual statutes are just the trees in the forest, but understanding the tax code as a whole and what it is trying to accomplish is just as important.

This is an abridged version of the huge two-volume tax code, and it was missing only one or two sections that we went over in class (sections which were very easy to just print myself). It's like half the size and half the price of the two-volume, so for basic tax law this book worked very well.
