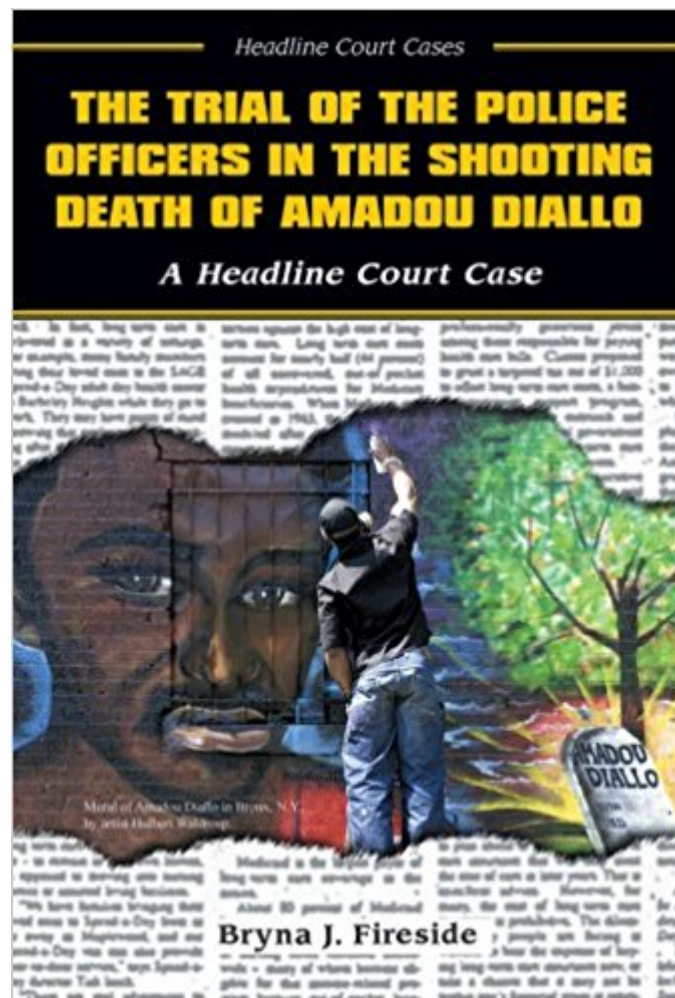

Without wasting a word, this fast-paced, balanced text, which reads like a mystery, dives right into the events of February 4, 1999, when four plainclothes police officers in the Bronx shot 41 rounds into a diminutive, unarmed immigrant from Guinea. The citywide protests that followed inspired a reexamination of the NYPD and its alleged discrimination against citizens of color, news of which eventually reached all the way to Diallo's West African community. The information unfolds through a combination of straight narrative, excerpts of court testimonies, and quick-reference descriptions of everyone involved in the eventual trial. After the climactic verdict, the book winds down with a chapter on the continuing civil divide and the efforts being made to ensure fair treatment for all. Black-and-white photos, a chronology, and discussion questions round out this gripping title in the Headline Court Cases series. Roger Leslie
