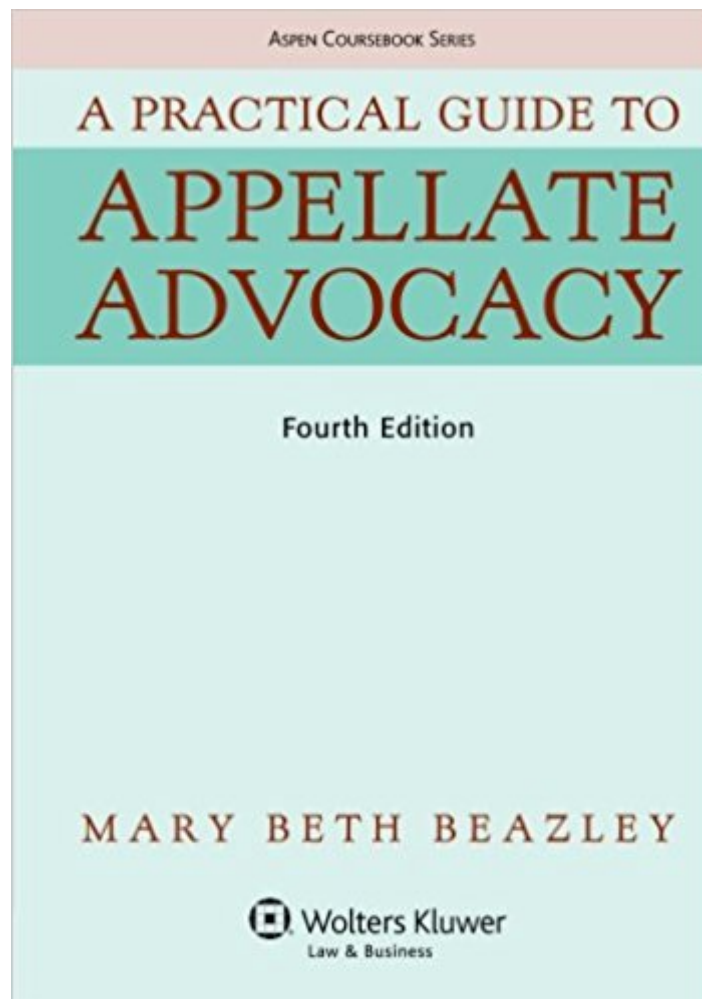

The long-time text for writing appellate brief. I didn't use it too much but it does have a lot of helpful information. It is too expensive, however. Also, this book hasn't changed in decades so if you can find a cheaper used version I would get that instead.

There are no "page numbers." Instead, the book only gives you the "location." No big deal? Think again if your professor assigns readings via page numbers. Good luck figuring out if page number 36 corresponds to location 2034 of 9065.

I thought this book was not particularly helpful. It had about 20 pages of useful rhetoric advice and actual helpful information. If not required, I would skip.
