


The book was found

Alan Bell has written a remarkable autobiography about his life as a victim of sick building syndrome. If the story ended there, it would be worth reading, but fortunately for us readers, Alan partially recovered from his sickness and has become an advocate for people who have been harmed by the toxic chemicals corporate America has unleashed on the environment. His is a horror story, plain and simple, that I could not put down. I stayed up until two o'clock in the morning last night and finished the book just a few hours ago. Let's start at the beginning with young Alan Bell an up and coming corporate lawyer for the Travelers Insurance Company in Fort Lauderdale, Florida. He had just moved into 110 Tower, a beautiful new office building. Almost immediately he began to experience symptoms that ranged from clogged sinuses, shortness of breath, hot flashes, nausea, fever, and so forth. His doctor prescribed antibiotics, which helped temporarily, but Alan's condition went from bad to worse and thus began a search for a doctor who might help him. His doctors were well meaning, but ineffective. He became a hopeless wreck of a man who was almost completely incapacitated and helpless. But then he got lucky and met Dr. Seastrunk in Dallas, Texas, who correctly diagnosed that Alan was a victim of toxic chemicals in the environment and prescribed for him the drug Neurontin. Almost immediately Alan felt some relief from his illness and thus began his slow road to recovery; by recovery I do not mean complete health and fitness, that was gone forever for him. Now I am on

He has teamed up with lawyers like Ed Masry, who some of my readers might remember as the lawyer from the film Erin Brockovich, and Jan Schlichtmann who was one of the lawyers featured in the film A Civil Action. I highly recommend both films which show the great damage corporate polluters can do to the environment and the innocent people who are harmed by their callous disregard for safety in the disposal of their toxic chemicals. No one can read AlanÃƒÂ¢Ã ¬Ã â„¢s book without dismay. Chapter after chapter he describes the human misery brought about by careless ÃƒÂ¢Ã ¬Ã âœ dare I say criminal ÃƒÂ¢Ã ¬Ã âœ corporate executives who care more about profits than they do about the safety and well-being of the general public. We have entered a period in the history of our country where our water, air, food, and even the homes we occupy can be the source of toxic chemicals that can make us sick. In his Epilogue Alan quotes a study from the Massachusetts Institute of Technology that reports nearly two hundred thousand deaths each year as a result of air pollution alone. And this tragic figure does not begin to reveal the deeper problem we face as we try to protect ourselves from being poisoned by toxic chemicals. Think just for a moment about the food we eat such as apples, strawberries, spinach, and the like that are heavily sprayed with pesticides. The fact is that we are being poisoned by corporate America and Alan BellÃƒÂ¢Ã ¬Ã â„¢s book is our wake-up call to protect ourselves and our loved ones. Poisoned is required reading for anyone who wants to understand the current state of affairs in our country as we attempt to slow down and then stop the destruction of our environment. Alan Bell is a fine writer; his book is a page turner. As mentioned at the beginning of this long review, I could not put it down. I was pleased to see his smiling face at Capistrano Beach, just down the road from where we lived in Dana Point, and I wish him all the best as he continues his crusade to awaken the American people to a most serious attack on our health and well-being.
