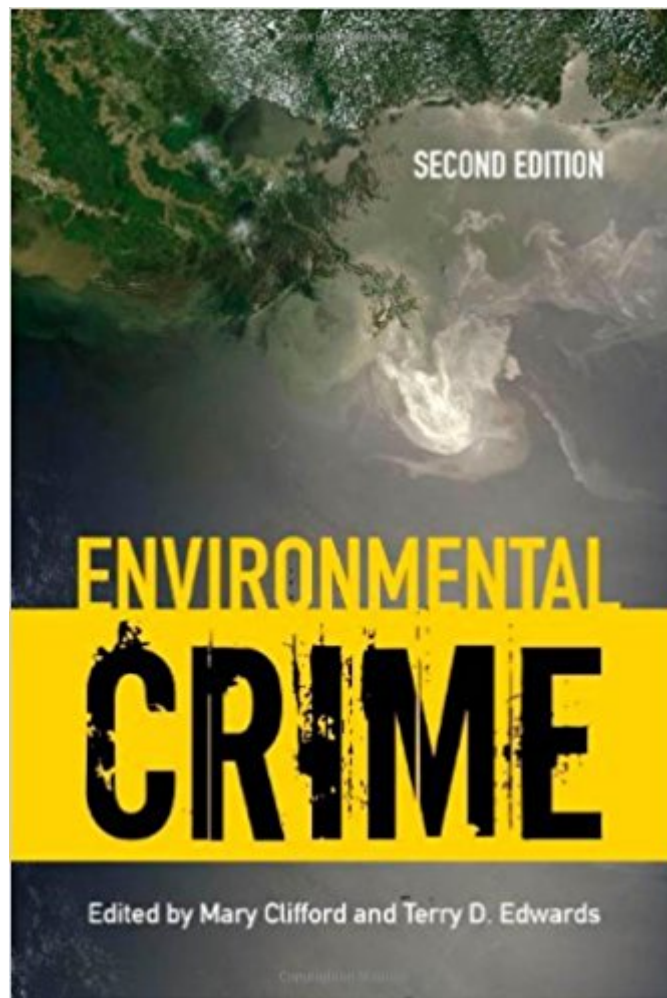

A little out of date but overall great book (there are not many of these types of books out there) introduction into Environmental Crime.

I don't feel that this book was organized effectively in many parts. In many of the chapters the concepts tend to jump around a lot, making it hard to grasp the central unifying concepts of each chapter. This book is not written in language that is hard to understand, but the way that the information is presented is somewhat muddled and convoluted.

Environmental Crime: Enforcement, Policy, and Social Responsibility is a pretty good overview of environmental issues. It would be good to read if you want to get the big picture on environmental issues. It covers philosophy, natural science, law, etc. I read it as a text for a college course. This was a small class and we had much discussion on the material. The book was well suited for such a class. Each chapter is by a different author and because of this it repeats itself a little. Much of the environmental crime data and examples given are from the early 1990's. Environmental crime has changed a lot from the early 1990's so the book was a little out of date even when printed in 1998. As a history and a basis for understanding it is great.
